Foundation for Appalachian Ohio Receives HUD/USDA Secretaries' Award

FAO One of Ten Recipients of National Award

Cleveland, OH – Across the nation, community foundations, private foundations, and corporate giving programs work to improve neighborhoods and the lives of the people who live in them. Today, the U.S. Department of Housing and Urban Development (HUD), the U.S. Department of Agriculture (USDA), and the Council on Foundations honored the work of place-based foundations when they announced the 2014 winners of the Secretaries' Award for Public-Philanthropic Partnerships.

The Foundation for Appalachian Ohio (FAO) earned the award for its outstanding partnership with the public sector. Through a partnership with the USDA, the Foundation worked hand-in-hand with local communities, including Perry County, to develop philanthropic resources to support their community development efforts. The awards were presented at the Council on Foundations' Fall Conference for Community Foundations in Cleveland.

"These foundations understand that strong communities connect families with the promise of living the American dream," said HUD Secretary Julián Castro. "Powerful outcomes occur when the philanthropic and public sectors come together to solve problems, enhance neighborhoods, and expand opportunity for others.
